INSTRUCTIONS FOR SIGNING AND DEPOSIT

Appointment of Proxy Holder

A holder of Senior Debentures has the right to appoint a person (who need not be a Senior Debentureholder) other than Tom MacNeill, President and Chief Executive Officer of the Company or, Andrew Davidson, Chief Financial Officer and Secretary of the Company, to attend and act on behalf of such holder of Senior Debentures at the Debentureholder Meeting or any adjournment thereof. Deposit

If this Form of Proxy is not dated, it will be deemed to bear the date on which it was mailed to the holder of Senior Debentures.
